Attached is the 2021, St. Justin Martyr Holy Name Society/Paul Misch Scholarship application. This two-year scholarship is open to all 8<sup>th</sup>. Grade students of St. Justin Martyr Parish, <u>regardless</u> of what school they may now be attending.

The scholarship was established to assist families in funding the tuition cost of a **Catholic High School**. The Holy Name Society will issue one scholarship in the amount of \$2,000 per year for two years.

One student will be chosen on the basis of financial need, academics, and a required essay. The scholarship will automatically be renewed in the sophomore year providing a satisfactory grade point average of 2.0 is maintained and the student meets the standards of the high school they are attending.

In order to be considered, the application must be completed entirely. A copy of the first two pages of your latest Federal Income Tax Return and verification of all "income for the current year earnings YTD (e.g. pay stubs, rent receipts, copies of checks) is required at the time the application is submitted. A copy of their last report card must be submitted. During the selection process, the identity of the individual student and family is removed from all information you submit. Applications not containing all of the required information will not be processed.
